GIVEAWAY TERMS

EFFECTIVE AS OF: 2 March, 2026

These **“Official Rules”** (these giveaway terms together with the documents, information published by us and further rules referred to in it) set out the terms which govern all our giveaway campaigns.

PLEASE READ THESE RULES CAREFULLY PRIOR TO PARTICIPATION OR ENTRY. OPEN ONLY TO INDIVIDUALS AGED 18 OR OLDER. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED BY LAW.

From time to time, **PanIQ Vegas LLC** (address: 3377 S. Las Vegas Blvd. Space 3300, Las Vegas, NV 89109; entity number: E0138292019-3) (hereinafter **“PanIQ Vegas”**) may offer sweepstakes and/or contests on its official third-party social media pages, such as Instagram, Facebook and TikTok (collectively, the **“Social Media Sites”**) and/or on its website (<https://paniquestaperoom.com/las-vegas/en> and/or any websites operated by PanIQ Vegas and/or any of these websites’ subpages, collectively, the **“Website”**). Each such giveaway or sweepstakes is referred to as a **“Giveaway”**. The information posted or communicated in our venue (PanIQ Escape Room Las Vegas: level 2M, Grand Canal Shoppes at the Venetian Resort Las Vegas; the **“Venue”**), on our Website and/or our Social Media Sites setting forth the method of entry, prizes and further conditions for each Giveaway are referred to as a **“Giveaway Rules”**. Please listen to and read the Giveaway Rules and these Official Rules before entering a PanIQ Vegas Giveaway. You agree that, by submitting an entry to a Giveaway, you will be bound by these Official Rules and the Giveaway Rules and you acknowledge that you satisfy all eligibility requirements. By participating in each Giveaway, you agree to the terms and conditions of PanIQ Vegas Website, which are available at <https://paniquestaperoom.com/las-vegas/en/terms-and-conditions>, and to our privacy policy, available at <https://paniquestaperoom.com/las-vegas/en/privacy-policy> incorporated herein by reference, and that your participation will be governed by, and you shall abide by, all of the following rules outlined herein.

ELIGIBILITY

Giveaways are open to individuals who are older of 18 years of age or the legal age of majority in their state of residence. The following individuals are not eligible to enter or win PanIQ Vegas Giveaways: current or former (within the immediately preceding 12 months) employees, officers, directors, and contractors of PanIQ Vegas, and anyone involved in the administration of the Giveaway, and any member of the immediate family (i.e., a parent, sibling, child or grandchild) or household of any of the foregoing individuals.

Individuals younger than 21 years may participate in the PanIQ Vegas Giveaways, but they are not eligible to win any prizes usable only by 21 or older individuals (such as free alcoholic beverages, etc.).

GIVEAWAY PERIOD

Each Giveaway begins and ends on the dates and times as specified in the Giveaway Rules (the “**Giveaway Entry Period**”). Entries will only be accepted during the Giveaway Entry Period.

HOW TO ENTER

Follow the instructions and fulfill the conditions in the Giveaway Rules to enter a Giveaway (the “**Entry**”). If the Entry is in the form of an original photograph or comment, you warrant and represent that:

- your Entry is original and does not infringe the intellectual property rights of any third party,
- you own or have the necessary licenses, rights, consents, and permissions to publish and exploit the Entry,
- the Entry does not feature trademarks, logos, or brand names other than PanIQ Vegas, and
- the Entry is not made for any improper purpose such as to intimidate or harass any individual or to ridicule, disparage, or embarrass PanIQ Vegas.

You grant a right to PanIQ Vegas to a royalty-free, irrevocable, transferrable, sublicensable, and non-exclusive perpetual license throughout the universe for use in any and all media whether now known or hereafter devised to use and exploit (including without limitation by reproduction, distribution, public display, adaptation, communication to the public, and/or public performance, and including for commercial purposes) the Entry (including your data provided for the Entry and the fact that you entered the Giveaway), waive to the full extent permitted by law any and all claims against PanIQ Vegas related to moral rights in the Entry, and except where prohibited, grant written permission to have the Winner’s name, likeness and identity used for promotional purposes by PanIQ Vegas without additional compensation.

Based on the license granted in the paragraph above, PanIQ Vegas may post your name and the fact that you entered the Giveaway and your results achieved in any sorts of competitions attached to the Giveaway in the Venue, on its Website and/or on its Social Media Sites.

To preserve the standards of a Giveaway, PanIQ Vegas may occasionally ask for additional information which will be used for fraud prevention.

No Entry shall contain any language or imagery which PanIQ Vegas deems, in its sole and absolute discretion, to be inappropriate, indecent, obscene, hateful, tortious, defamatory, or that promotes discrimination on the basis of race, gender, religion, nationality, disability, sexual orientation, or age. PanIQ Vegas reserves the right, in its sole discretion, to disqualify any Entry that contains any such language or imagery or which otherwise may be in violation of any law.

Late, incomplete and/or inaccurate entries and entries not complying with these Official Rules and other rules and conditions referenced herein are subject to disqualification. Any form of automated entry, including by the use of macros, scripts or bots, will be disqualified. Furthermore, by entering, each Participant represents and warrants that each Entry complies with these Official Rules in full.

PanIQ Vegas reserves the right in its sole discretion to disqualify and/or not accept any Entry that PanIQ Vegas determines does not or is likely not to comply with these guidelines.

Number of Entries: One Entry per person, unless otherwise stipulated in the Giveaway Rules, except for the immediate prizes (i.e. when there are immediate, on-site drawn prizes, an individual may participate more occasions in the immediate prize drawings, however, for the later-drawn and main prize drawings, each individual may Enter once per Giveaway only). Any Entries over the limit will be deemed ineligible and will not be entered into the Giveaway. **For the Giveaway called “Spring Challenge”, starting 2 March, 2026 and ending 19 April, 2026), multiple entries are enabled for a single person.**

By participating, each person who participates (each a “**Participant**”) agrees to be fully and unconditionally bound by these Official Rules and represents and warrants that he/she meets the eligibility requirements set forth herein.

By entering a Giveaway, you will not be eligible to receive any prizes awarded in any other Giveaway unless you enter each Giveaway separately.

In case the Giveaway is involved in a team competition (i.e. the Spring Challenge, which awards the fastest escaping teams), the team leader, as a natural person, shall be deemed as the participant in the Giveaway. This was, every team must choose a team leader, who - as a person - will meet the eligibility criteria and will be deemed as the participant. In case the team wins, the team leader - as participant - will be provided with the prizes and the team leader shall be deemed as the winner of the prize.

PRIZE(S)

Prize shall be as stated in the Giveaway Rules. No cash or other prize substitutions are permitted except at PanIQ Vegas’s sole discretion. The prizes are non-transferable. Each winner will be responsible for paying all costs and expenses related to a prize that are not specifically mentioned, including, but not limited to, income taxes, and any other expenses that might reasonably be incurred by the winner in receiving or using the prize. **In case of cash prize(s), PanIQ Vegas shall have the right and obligation the deduct the taxes payable for the cash prize and pay only the remaining (after-tax) amount to the winner.** The winner should consult a tax professional to discuss the winner's particular situation. Each winner may be required to submit his/her social security number or taxpayer ID to PanIQ Vegas in order to claim a prize and in order to allow PanIQ Vegas to complete the tax deductions and payments.

If a winner does not provide his/her social security number or taxpayer ID or other documents and information as requested by PanIQ Vegas, the winner will no longer be eligible to receive the prize and the prize will be forfeited and returned to PanIQ Vegas.

Each prize will be awarded “AS IS” and WITHOUT WARRANTY OF ANY KIND, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). If you win a prize, you may not transfer, assign, or redeem the prize for cash. PanIQ Vegas reserves the right to substitute a prize with a gift card or other prize of value equal to or greater than the value paid by PanIQ Vegas while setting up the Giveaway.

PanIQ Vegas shall - except for the main prize - have the right to change the quantity and type of the rewards, i.e. vary the reward pool any time during the Giveaway - based on the available stock of the prizes - in its sole discretion.

GRANT OF RIGHTS

By accepting the Prize, the winner agrees, where imposing such condition is legal, to grant PanIQ Vegas and its designees the irrevocable, royalty-free right to publish, disseminate, and use the person's name, photo, and city and state of residence without further notice, permission, or consideration, in perpetuity, throughout the world, in all media and formats now known or hereafter invented, in connection with the execution and promotion of the Giveaway, and will confirm consent to such use in writing upon request.

SELECTING AND NOTIFYING PRIZE WINNER

PanIQ Vegas will award a prize to one or more individuals who enter the Giveaway as specified in the Giveaway Rules. The start and end dates and times of the Giveaway, method of entry and prize(s) will be specified in the Giveaway Rules. Winner(s) will be selected by random drawing from among all eligible entries received. Odds of winning depend on the number of eligible entries received.

Limit one prize per person per Giveaway, unless otherwise stated, except for the immediate prizes (i.e. when there are immediate, on-site drawn prizes, an individual may participate more occasions in the immediate prize drawings, however, for the later-drawn and main prize drawings, each individual may Enter once per Giveaway only).

The Winner will be notified via direct message to the Social Media Site account or email associated with the Winner's Entry, and must respond within two (2) days to claim the prize. In case the winner does not respond within the deadline, PanIQ Vegas shall have the right to withdraw the prize and award it to another winner (i.e. to choose another winner). This case, the original - non-responsive - winner loses the prize and shall have no further claims against PanIQ Vegas.

TERMS

All federal, state, and local laws and regulations apply, and the Giveaway is void where prohibited. PanIQ Vegas reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Giveaway should (in its sole discretion) a virus, bugs, non-authorized human intervention, fraud or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of the Giveaway. In such a case, PanIQ Vegas may select the recipients from all eligible Entries received prior to and/or after (if appropriate) the action taken by PanIQ Vegas. PanIQ Vegas reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Giveaway or who violates these Official Rules. PanIQ Vegas is not responsible for lost, late, illegible, incomplete, damaged, mutilated, misdirected, misdelivered, or delayed Entries, or for technical or human errors or failures of any kind in connection with the submission, transmission, processing or selection of Entries or the winning Entry, including without limitation any malfunctions or failures of computer hardware, computer software, networks or telephone equipment or any technical problems or traffic congestion on the Internet or at any website or late, lost, damaged, or postage due mail, or any combination thereof. PanIQ Vegas shall not be responsible for retaining copies of any Entry. The word "including" is used in these Official Rules to mean "including but not limited to". PanIQ Vegas may, in its sole discretion, disqualify any individual found to be acting in an unsportsmanlike or disruptive manner or with intent to annoy, abuse, threaten or harass any other person.

If there is a dispute as to the identity of an entrant, the prize will be awarded to the authorized account holder of the Social Media Site account associated with the winning Entry, as registered with the Social Media Site at the actual time of entry, or, if applicable, to the authorized account holder of the email address associated with the winning Entry, as registered with the organization responsible for assigning email addresses for the domain associated with the winning Entries submitted email address. PanIQ Vegas shall have no liability for a winner's failure to receive notices due to winners' failure to check their Social Media Site messages, or for emails sent to spam, junk e-mail or other security settings or for Winners' provision of incorrect or otherwise non-functioning contact information.

DISPUTES

The courts of Nevada, U.S. have exclusive jurisdiction to settle any dispute or claim arising out of or in connection with this Official Rules or its subject matter or formation (including non-contractual disputes or claims) (hereinafter: **"Dispute"**).

No Class Action Matters: We each agree that we shall bring any Dispute against the other in our respective individual capacities and not as a plaintiff or class member in any purported class, representative proceeding or as an association. In addition, we each agree that Disputes shall be resolved only on an individual basis and not in a class, consolidated, or representative action and that the court may award relief (including injunctive relief) only on an individual basis.

No Jury Trial: you and PanIQ Vegas agree to waive any right to a trial by jury.

MISCELLANEOUS

You agree that PanIQ Vegas's decisions related to the Giveaway and all distribution of prizes are final. Each winner agrees that, by participating in the Giveaway, PanIQ Vegas may use the winner's name in any manner and in any medium for its promotional purposes without additional compensation, including posting in a winner's list, except where prohibited by law, and PanIQ Vegas may be required to disclose the winner's address to state regulatory authorities.
